

APPLICATION FOR LIQUOR LICENSE
CITY OF BRECKENRIDGE HILLS, MISSOURI

(Original - Renewal - Relocation)

To the Council of the City of Breckenridge Hills:

The undersigned _____ hereby makes application for a permit or licence to :

1. Intoxicating liquor may be sold at retail in the original package, not to be opened or consumed on the premises of the vendor, upon the issuance of a license by the Council of the City of Breckenridge Hills for which license shall be paid to the City Clerk or to his/her duly authorized deputy the sum of One Hundred, Fifty Dollars (\$150.00).
2. Malt liquor containing alcohol in excess of 3.2% by weight, and not in excess of 5% by weight, and manufactured of pure hops and/or pure extraction of hops and/or pure barley malt and/or wholesome grains or cereals, may be sold at retail, in the original package, not to be opened or consumed on the premises where sold, upon the issuance of a license by the Council of the City of Breckenridge Hills for which license shall be paid to the City Clerk or to his/her duly authorized deputy the sum of Twenty Two Dollars and Fifty Cents (\$22.50).
3. Malt liquor containing alcohol in excess of 3.2% by weight and not in excess of 5% by weight, manufactured from pure hops or pure extract of hops or pure barley malt or wholesome grains or cereals and wholesome yeast and pure water, or light wines containing not in excess of 14% of alcohol by weight exclusively from grapes, berries, and other fruits and vegetables, or both such malt liquor and wine by the drink at retail for consumption on the premises where sold, may be sold upon the issuance of a license by the Council of the City of Breckenridge Hills, to the person, partnership, or corporation desiring to sell such malt liquor or wine or both, by the drink at retail for consumption on the premises where sold which license shall be paid to the City Clerk or to his/her duly authorized deputy the sum of Fifty Two Dollars and Fifty Cents (\$52.50).
4. Sale of intoxicating liquor as provided in the three paragraphs next proceeding, as well as sale of intoxicating liquor content in excess of 5% by weight, at retail by drink for consumption on the premises of the licensee, may be made upon the issuance of a license by the City Council of the City of Breckenridge Hills, for which license there shall be paid to the City Clerk or to his/her duly authorized deputy the sum of Four Hundred Fifty Dollars (\$450.00) per year.
5. Sales of intoxicating liquor at restaurant bar for consumption on the premises of a restaurant bar may be made upon the issuance of a license by the City Council of the City of Breckenridge Hills, for which license there shall be paid the City Clerk the sum of Three Hundred Dollars (\$300.00) per year.
6. Sell malt liquor containing not in excess of 3.2% alcoholic content by weight, at retail, by the drink for consumption on premises where sold for which license there shall be paid to the City Clerk or to his/her duly authorized deputy the sum of Thirty Seven Dollars and Fifty Cents (\$37.50) per year.

7. Sell intoxicating liquor in the original package between the hours of 9:00 a.m and 12:00 midnight on Sundays upon the issuance of a special license to do so by the City Council of Breckenridge Hills, for which special license there shall be paid to the City Clerk or to his/her duly authorized deputy an additional fee for the sum of One Hundred Fifty Dollars (\$150.00) per year.

On the following described premises in the City of Breckenridge Hills Missouri to wit: _____
_____ for the term ending on the last day of February _____, under and subject to the provisions of the Ordinances of the City of Breckenridge Hills, Missouri relating to the regulation and control of the sale of intoxicating liquor.

Applicant hereby agrees that if a permit or license is granted upon this application, that applicant or any officer, agent, employee or servant of applicant will not violate any provision of the said Ordinance of the City of Breckenridge Hills, or any law of the State of Missouri while in or upon the premises of the applicant herein described, or knowingly allow any other person to do so. Applicant hereby agrees that if the applicant shall violate any of the provisions of said Ordinances of the City of Breckenridge Hills, Missouri or of the Acts of the General Assembly of the State of Missouri under the Authority of which said Ordinances were adopted, relating to the regulation, control, sale, manufacture, possession, transportation or distribution of intoxicating liquor, or fails to obtain and at all times, have a license from the State Supervisor of Liquor Control of Missouri, or shall have made or there shall have been made on the applicant's behalf a false affidavit in applying for this license, the Council of the City of Breckenridge Hills, Missouri may revoke any permit or license issued upon this application in the manner now or hereafter provided by Ordinance.
